### **UK International Transfer Addendum**

To the extent that Personal Data originating in the UK is Processed by Supplier on behalf of SHEIN or a SHEIN Group Affiliate and is transferred to a country or territory not recognized under UK adequacy regulations, and where no other transfer mechanism under Applicable Privacy Laws authorizes the transfer, the following terms shall apply and are incorporated into the DPA by reference, reflecting the International Data Transfer Addendum ("UK Addendum") issued by the UK Information Commissioner's Office (ICO) to the EU SCCs:

## **Part 2: Mandatory Clauses**

## SHEIN

The Mandatory Clauses of the ICO's International Data Transfer Addendum (version A1.0, in force as of 21 March 2022) shall apply as published by the ICO at ICO International Data Transfer Addendum, and any later version formally published by the ICO.

Transfer Risk Assessment: Supplier shall cooperate reasonably with SHEIN in conducting any Transfer Risk Assessment required under UK GDPR, and shall provide such technical, organizational, legal or other information as reasonably requested to assess whether the transfer safeguards will provide protection for data-subjects' rights equivalent to those under UK law.
